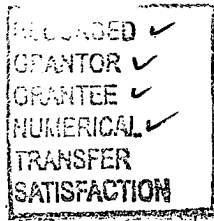

WHEREAS on April 4, 2008, the Willow Brook Homeowners Association as Declarant executed a certain Sixth Amended Declaration and Restatement of Covenants, Restrictions and Easements for Willow Brook Homeowners Association (hereinafter called "Covenants"), which was filed in the office of the Butte County Register of Deeds, South Dakota on April 4, 2006, as Document #2008-744 covering the following described real property:

Lots 1A, 1B, 2A, 2B, 3A, 3B, 4A, 4B, 5A, 5B, 6A, 6B, 7A, 7B, 8A, 8B, 9A, 9B, 10A, 10B, 11A, 11B, 12A, 12B, 13A, 13B, 14A, 14B, 15A, 15B, 16A, 16B, 17A, 17B, 18A, 18B, 19, 21, 23A, 23B, 25A, 25B, 27A, 27B, 29A, 29B, 31A, 31B, 33A, 33B and common Lots A, B and C; as located in Willow Brook Subdivision, a subdivision of a portion of Tract No. 100 of the Force Aeriennes Addition to the City of Belle Fourche, NW¼ of Section 23, T8N, R2E, B.H.M., Butte County, South Dakota

(hereafter called the "Property").

WHEREAS Owners are the owners of the above-described Property

WHEREAS, the Covenants above referenced provide in Article VIII Section F(1) thereof "The purpose of these Covenants includes a desire to maintain uniformity in appearance and condition. To that end, repair, maintenance, or replacement of exterior components, including but not limited to windows, garage doors, storm doors, exterior doors, paint and trim, shall be made as close to the original as is reasonably practical."

WHEREAS, the Covenants above referenced provide in Article VIII Section O thereof, "The foregoing restrictions and covenants may be amended, altered or revoked at any time upon approval of the owner or owners of two-thirds of the dwelling units or upon approval of such percentage of the dwelling units as may be otherwise required by law."

WHEREAS, Owners consisting of two-thirds of the dwelling units desire to amend Section VIII.F(1) of the Covenants.

NOW THEREFORE, Owners of Lots 1A, 1B, 2A, 2B, 3A, 3B, 4A, 4B, 5A, 5B, 6A, 6B, 7A, 7B, 8A, 8B, 9A, 9B, 10A, 10B, 11A, 11B, 12A, 12B, 13A, 13B, 14A, 14B, 15A, 15B, 16A, 16B, 17A, 17B, 18A, 18B, 19, 21, 23A, 23B, 25A, 25B, 27A, 27B, 29A, 29B, 31A, 31B, 33A, 33B for themselves, their successors, and assigns, hereby amend the Covenants as to the Property described above as hereinafter set forth (hereinafter "Amended Covenants"):

Amended Covenants

Amendment 1: Article VIII Section F(1) of the Covenants is amended to provide, in its entirety, as follows:

F. General Appearance of Dwelling Units, Fences, Unit Expansion, Construction, Repair and Additional Structures:

- (1) The purpose of these Covenants includes a desire to maintain uniformity in appearance and condition. To that end, if windows are repaired or replaced, exterior components including but not limited to any trim shall consist of cement fiberboard or comparable maintenance-free product and shall match the color of the existing siding. If the windows are trimmed, the trim shall be three (3) inches wide unless the window manufacturer requires trim exceeding three (3) inches wide, then the window trim may be the necessary width to meet manufacturer warranty specifications. The repair, maintenance, or replacement of other exterior components including but not limited to garage doors, storm doors, and exterior doors shall be made as close to the original as is reasonably practical.

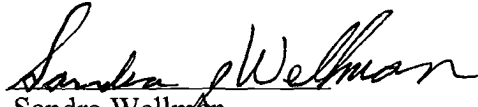
Binding Effect. These Amended Covenants shall be deemed appurtenant to and run with 1A, 1B, 2A, 2B, 3A, 3B, 4A, 4B, 5A, 5B, 6A, 6B, 7A, 7B, 8A, 8B, 9A, 9B, 10A, 10B, 11A, 11B, 12A, 12B, 13A, 13B, 14A, 14B, 15A, 15B, 16A, 16B, 17A, 17B, 18A, 18B, 19, 21, 23A, 23B, 25A, 25B, 27A, 27B, 29A, 29B, 31A, 31B, 33A, 33B described in these Amended Covenants and are perpetual and continuing. These Amended Covenants shall be binding upon and burden and inure to the benefit of the parties hereto, their heirs, successors and assigns to the real properties herein described.

Other Covenants Unaffected. The Covenants as referenced herein shall remain effective, run with the land, and be binding upon the Property in accordance with their respective terms and conditions.
