- B. If the request is "Approved With Changes," the Unit owner may complete the modification(s) only if he/she revises the proposed work as required by the Board.
- C. Although a Unit owner may participate in making the modifications, a licensed contractor must oversee and be responsible for the work.

I. APPLICABLE COVENANTS:

Section VIII, Paragraph F of the Sixth Amended Declaration and Restatement of Covenants, Restrictions and Easements for Willow Brook Homeowners Association provides, in pertinent part, as follows:

The purpose of these Covenants includes a desire to maintain uniformity in appearance and condition. To that end, repair, maintenance, or replacement to exterior components, including but not limited to windows, garage doors, storm doors, exterior doors, paint and trim, shall be made as close to the original as is reasonably practical. All such repairs, maintenance, or replacements are subject to the approval of the Board.

... in no event shall any such replacement or modification be performed without the prior approval of the Board, and in no event shall the Board approve any such replacement or modification unless the same is performed by a licensed contractor.
